Moving T-Ball to Friday nights was a big change, but it turned out to be a huge win. The atmosphere, the numbers, the competition—it all just worked. And there was some seriously good talent on display across all age groups.

On the baseball side, shifting to the Southern Titans comp on Saturdays was another big step for us. It was something new, but it really paid off. Having the younger kids early and then rolling into Little League gave the whole morning a great club feel.

A couple of big highlights:

- Our Little League team winning the comp
- Our Intermediate League team making finals

Also great to see 7 of our players represent Southern Titans, and 2 girls make the West Coast Rays at the State Champs—that's something the whole club should be proud of.

Machine Pitch on Monday nights was awesome as well. We had three strong teams, and it's great seeing that pathway building into Little League.

Our State T-Ball program was another big success great results in all age groups

- 9B and 11B finished 2nd
- 12s got 3rd in A grade
- 10s got 4th
- 9A finished 5th

, so a big thank you to everyone involved there. Plenty to be excited about for the future.

We also managed to get two winter sub-junior softball teams up and running, which is huge for the club. Big thanks to Casey and Tahnee for the work they've put in behind the scenes to make that happen.

Off the field, things were just as strong.

Massive thanks to Henry for sponsorships—every single team having a sponsor is a first for this club. We brought in about \$21,000, plus another \$10,000 from Hugh Jones.

Because of that, we've been able to upgrade equipment, get new shirts, and even put in a new pitching mound—so that's a big step forward for us.

difference. The club is in a really strong position because of the work you've all put in, and it's definitely appreciated.
